#### **Election Integrity**

The Election Integrity Committee has been working in these major areas:

- Clean voter rolls. Given past DMV voter registration issues, we will use RNC data to ensure former GOP voters who are newly nonaffiliated intended the change. We'll cross reference this with USPS undeliverable data and pass the info to counties so they can clean voter rolls at precinct level.
- Mis- Dis- & Mal-Information. Oregon's Secretary of State is procuring a contract using thirdparty foreign tech to identify and track so-called MDM threats by surveilling and tracking US Citizens as MDM threats.
- We are monitoring the state's new ORVIS voting system, which involves cloud hosting to tally votes. Many specifications show the system performing county functions. Counties will access Oregon Votes on the cloud which will connect to their local tally machines, resulting in increased vulnerability. The system's launch is behind schedule, so use of the old system has to be extended.
- We've developed resources to educate Oregonians about Ranked Choice Voting (RCV), coming to your ballot in 2 measures—HB2004 and HB3509.
- We have held educational workshops statewide, including hand-counting ballots, GOTV, voting system integrity, & more.

# Rules Margie Hughes, Chair

In 2023, the Rules Committee worked diligently on preparing special rules for each meeting—election rules, platform rules, and rules for the Convention to Select National Delegates.

In 2024, we will review and update ORP Standing Rules, as well as continue to prepare special rules needed for each meeting.

#### **Energy**

The newly named Energy Committee has been working on the following:

- Identifying and tagging opponents of Eugene's Natural Gas Ban in the GOP Data Center
- Promoting the new Energy plank of ORP's Platform to candidates.
- We hope to develop curriculum for candidates and county parties to harness the energy plank for messaging and voter outreach.
- We hope to invite subject matter experts to engage in development of messaging, curriculum, and possibly instruction for ORP.
- We are highlighting news from recent winter storm related power outages to expose the perils of eliminating energy choices.
- We employ social media to alert voters to energy news involving Biden and Kotek administrations, state legislature, & local measures.

#### Meetings, Trainings, and Events, Oh, My!

Last year ORP sponsored a wealth of trainings to help us all in our work to elect Republicans.

## News from House Republicans

Last week Oregon House Republicans introduced a bill to end Measure 110 as we know it.

This is an important step to ending the crises of drug addiction, homelessness, and crime that have plagued our
