## RANKED CHOICE VOTING?

2. RCV disenfranchises those who vote for fewer candidates than the rounds of counting. If 5 candidates run, but the voter ranks only 2 that are eliminated in the first 2 rounds, their ballot doesn't count in the final tally of votes. Proponents call this "ballot exhaustion," but it's really "ballot trashing" since those ballots are not counted at all in the final tally.

- 3. RCV is not a run-off between candidates, despite proponent claims. It favors incumbents and name recognition, and reduces competitiveness of fresh candidates and fresh voices.
- 4. Complex strategy can be required to support your favorite candidate. This can discourage voter participation. In some cases, voting for your favorite candidate as 1st choice can actually hurt his or her chance of election.
- 5. Oregon's AG has admitted the current electronic voting system can be hacked. With a computer algorithm deciding the election at a centralized location, RCV will create nightmares for forensic auditors and undermine already low voter confidence.

- 6. Implementing RCV requires large expenditures by counties and state. Shouldn't we spend money to secure our current election system first?
- 7. Strategic voting and vote-splitting **RCV** systems allow to manipulated. Voters rank candidates in a way that prevents a less-favored candidate advancing rather than ranking them according to true preference. This strategy can also be used to target less informed voters or those more easily confused by the system.
- 8. Research shows strong evidence of higher levels of "ballot exhaustion" among ethnic and minority voters. Similar rates are expected among the elderly, the less-informed, and the less engaged voters. Disenfranchised by a complex system, some fall prey to manipulation by crafty arguments. Others simply refuse to vote because the system is too hard to understand or they have difficulty ranking all the candidates.
- 9. Under RCV, majority-group candidates lack incentives to appeal to minority-group voters. RCV has the potential to eliminate minority parties and voter concerns.

ne of the most deceptive ideas ever to be peddled to a naïve electorate is Ranked Choice Voting or its variations—Star Voting or Instant Run Off Voting or Multiple Choice Voting. Make no mistake: RCV is coming up for a vote in Oregon this November. RCV is a snake oil sales pitch that sounds reasonable until you realize too late that you have been flimflammed out of your vote and the public has been manipulated into a computer-derived configuration of the vote.

In RCV, each voter has the chance to rate all candidates for an office in order of preference. When the votes have been counted and no single candidate has won a majority of the votes, the candidate with the least amount of votes is dropped, and those who voted for that candidate get to vote again for their second choice candidate. This continues until a candidate receives a majority of the votes in that round. Sound good? Think again!

1. Voting is difficult to trace: Computer algorithms decide who won an election in complex maneuvers, which are nearly impossible to trace and verify afterward. You will never know for whom your vote was actually cast.

We will have candidates introduce themselves (2 minutes). Then, we will have a lightning round of 12 yes-or-no questions and then move on to the audience asking questions. This will be done by candidate category, which includes the Commissioner, Senate, and House. We hope you'll join us!

### **Human Trafficking**

Committee Report Part I (to be continued)

uman trafficking is a crime in which force, fraud or coercion is used to compel a person to perform labor, services, or commercial sexual activity.

Trafficking in persons is a human rights abuse. The three most common forms of human trafficking are:

- Sex trafficking
- Labor trafficking (forced labor)
- Child soldiering



**Force, Fraud, and Coercion -** Traffickers use force, fraud, and coercion to compel victims to perform labor or services or commercial sex acts. Here are some examples of force, fraud, and coercion drawn from actual cases. This list is not allinclusive.

#### Force:

- Physical assault—being hit, kicked, punched, stabbed, strangled, burned, shot, raped
- Confinement—being locked in a room or closet, handcuffed, tied up, bound, or otherwise physically prevented from moving or leaving a situation
- Drugging a person to incapacitate him/her

#### Fraud:

- False promises—better job, or pay, new life in the U.S., better circumstances for one's family
- Use of fraudulent travel documents—passports or visas
- False advertising

#### **Physical Coercion**

- Putting a gun to someone's head
- Holding a person at knifepoint
- Threatening to hit or hurt someone

#### **Psychological Coercion**

- Threats of physical harm against the victim or victim's family
- Blackmail (threatening to release nude photos of a person)
- Threats of deportation or jail
- Showing a person a dead body and intimating that without cooperation, he/she will end up the same way.
